UPDATES

Department of Health Testing Bulletin - July 2024

On July 15th, the Mississippi Department of Health released an **official bulletin** related to new testing requirements for cannabis and cannabis products. These new testing requirements were adopted in January of this year, but went into effect on July 29th.

3MA will continue to monitor the effect these changes may have on the broader industry.
