

What is the MMCP Licensing Portal?

The official web portal for the Mississippi Medical Cannabis Program, used to manage:

- **Business License Applications**
 - Dispensaries
 - Cultivators
 - Processors
 - Testing Facilities
 - Transportation Entities
 - Disposal Entities
 - Research Entities
- **Practitioner Certifications**
- **Patient Applications**
- **Caregiver Applications**
- **Work Permit/Agent Applications**

Key Features

Licensees:

- Start, manage and edit business applications & renewals.
- Download digital copies of approved licenses.
- Check the status of applications and licenses.

Practitioners:

- Start, manage and edit business applications & renewals.
- Check the status of applications and licenses.

Patients/Caregivers


- Start and manage patient & Caregiver applications.
- Check the status of patient and caregiver applications
- Check the current patient allotments available in real-time.

Work Permit Holders

- Start and manage work permit applications.
- Check the status of applications and apply for updates/renewals.


How to Register an Account

Things to Remember

Managing Multiple Accounts

Separate accounts are required for different application types (e.g., individual vs. business).

To add a new account:

- *Navigate to the "Account" tab.*
- *Select "Add Individual" or "Add Business."*
- *Follow the prompts to create the new account.*
- *Switch between accounts using the dropdown menu in the upper left corner of the dashboard.*

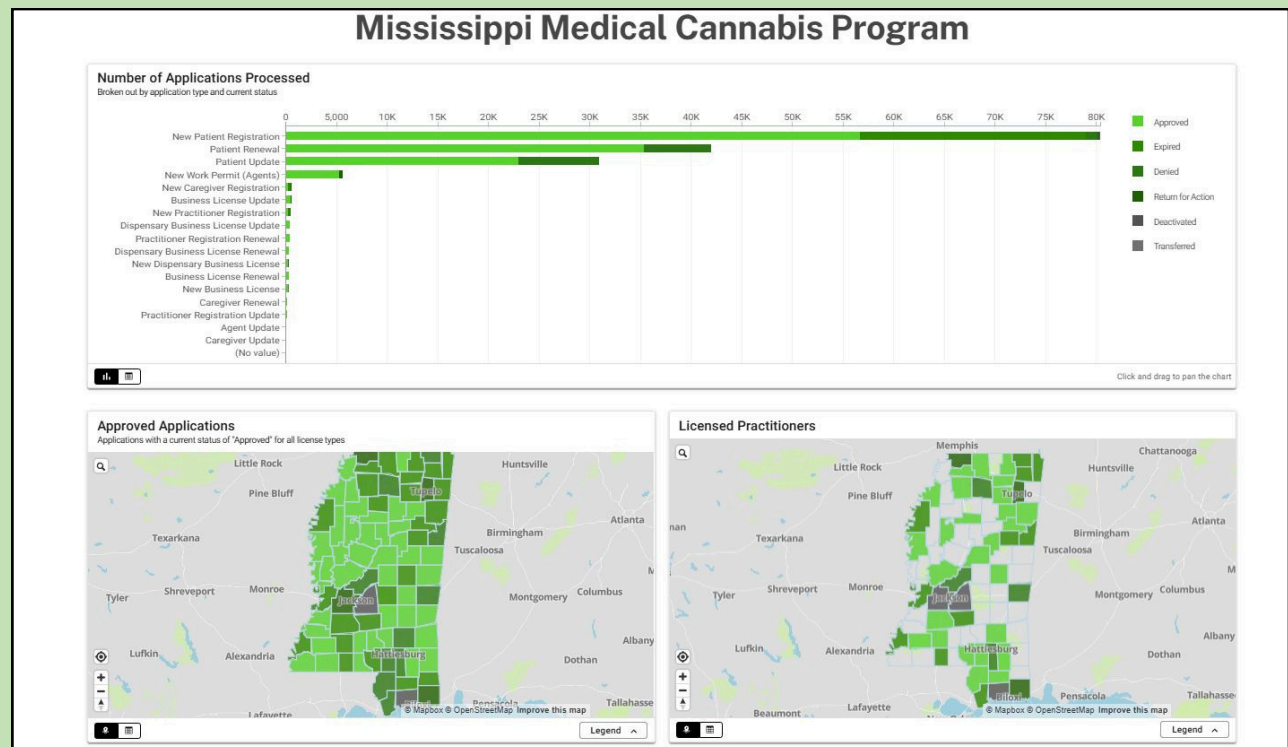
