Legislative Update - April 2025

This Sunday (4/6/25) marks the end of the 2025 Regular Session for the Mississippi Legislature.

Last month, Governor Reeves signed **Senate Bill 2748** into law— an important, patient-first update to Mississippi's medical cannabis program. Beginning in July, the state will adopt a more consistent formula for how patient allotments are calculated, ensuring alternative forms of cannabis (concentrate and edible forms) are treated more similarly to smokable flower in the patient allotment formula. This technical change helps remove barriers and gives patients more flexibility in choosing the method of relief that works best for them.

Under the updated allotment system, 1 MMCEU (Medical Marijuana Cannabis Equivalency Unit) will now equal:

- 3.5 grams of cannabis flower

- 1000mg of total THC in concentrate products
- 1000mg of total THC in edible products

This change brings alignment across product types and reflects a more patient-centered approach to care.

We're deeply grateful to the Mississippi Legislature, the Departments of Health and Revenue, and our fellow 3MA members for their collaboration and support. Together, we're committed to building the most accessible, effective, and patient-friendly medical cannabis program in the country.
