3MA v City of Jackson - Stay Order Successfully Executed

In March, the Jackson, MS city council passed a series of ordinances specific to licensed medical cannabis businesses operating within city limits. These ordinances place unnecessary and burdensome restrictions on dispensaries, cultivators, processors, and other participants in the Mississippi Medical Cannabis Program. If enacted as written, they would have significantly disrupted lawful operations and penalized compliant businesses with virtually no notice—taking effect just 30 days after passage.

Thanks to the swift response of 3MA and our members in the Jackson area, we filed a legal challenge that resulted in a 45-day stay, delaying enforcement of the ordinances. This critical window has allowed us to develop and submit a revised, more balanced version of the ordinance for the city's consideration.

However, this legal effort has created unexpected expenses that were not accounted for in 3MA's annual budget.

We're asking for your support to help cover the legal costs associated with this challenge. Your contribution will ensure 3MA can continue to stand up against harmful overregulation and protect the rights of patients, providers, and businesses across Mississippi.

AGREED ORDER STAYING ENFORCEMENT OF
ORDINANCE PENDING APPEAL

THE COURT, being advised that the parties are in agreement as to the particulars set forth herein, does hereby find and order, as follows:

1. That, on March 18, 2025, at a Special Call meeting of the City Council, the City of Jackson adopted an Ordinance that created Chapter 114, Article V for the purpose of regulating Medical Cannabis Business Activities ("Ordinance"). Doc. 2 at p. 8.

National

- **A Nebraska bill** that would ban most consumable hemp products has stalled until at least next year over disagreements among lawmakers about including protections for medical cannabis products.
- **Texas lawmakers sent Gov. Greg Abbott (R) a bill to significantly expand the limited medical cannabis program** by adding new qualifying conditions like chronic pain and traumatic brain injury and approving more product forms like vapes and lotions, as well as authorizing additional dispensary locations.
- **More than a fourth of Native American tribes in the continental U.S. are now involved with marijuana or hemp programs**, according to a new map from the Indigenous Cannabis Industry Association and the law firm Vicente.
