



Patient Card Count Growth Since June 2024

Since June 2024, when data for both active and total patient cards became available, total card counts have grown by an average of 92 per day, while active card counts have increased by an average of 50 per day.







Card Count Attrition

- Analysis of 1,500 cards issued six and twelve months ago shows attrition of ~10% at six months, rising to ~45% at twelve months, a clear renewal hurdle at the one-year mark. While some patients may obtain new cards after expiration, we have no reliable data to support this.
- Based on gross issuance over the past year, we project roughly 37 cards per day will expire over the next six months. This equates to a net gain of 100 active cards for every 137 new cards issued. To sustain active card growth of 50 per day, issuance must average at least 87 new cards daily.

6 Months Post Initial Card Issuance


12 Months Post Initial Card Issuance






Top 10 Counties by Patient Population






Licensed Dispensaries








Monthly medical cannabis spend per active patient has consistently averaged around \$200.






Processed Cannabis Production by Type



Top Industry Concerns



R&D Testing

(Heavy Metals)

Problem - Currently no option to precheck for heavy metals/pesticide contamination.

Solution - Allow for Heavy Metal/Pesticide R&D testing prior to a full-panel CoA.



Disassembly of Hardware

(Vape Carts)

Problem - New MMCP Regulations require manufacturer disassembly instructions for Vape Hardware.

(Most hardware is not meant to be dissasembled)

Solution - Allow for hardware and contents to be submitted for testing separately.

2026 Policy Goals

Potency Reform

Raise Potency limit on cannabis flower from 30% to 40%.

Remove Potency limit on infused and concentrate products.

Maintain Strict **Testing**, Labeling & **Packaging Requirements**



30% THC → **40%** THC



60% THC → NO LIMIT

Eligibility Reform

Allow for practitioners to certify patients for up to 24 months (vs. 12)

Remove mandatory 6-month followup requirement from Miss. Code

Practitioners maintain discretion on length of card validity time



Patient Card Valid up to 24 months



Mandatory 6-month followup removed

"Right to Try" Expansion

Add provision allowing medical cannabis access for any condition

Practitioners can determine if traditional treatment options are ineffective

Maintain **bona fide patient**practitioner relationship requirement
